- OFFICIAL 2021 TOURNAMENT RULES -

1. RULES: The following rules will be in effect. Enforcement and all interpretations of these rules will be done solely by the Tournament Director. All decisions of the Director will be final and binding without protest or appeal. Violations of these Rules are Grounds for Disqualification and Forfeiture of the Entry Fee.

2. ALLOWED ENTRY: The Director Reserves the Right to Refuse Entry to Anyone for Any Reason.

3. SAFETY: COVID Restrictions are in Effect at the Marina, MASKS and DISTANCING are REQUIRED.

All boats shall comply with all 2021 U.S.C.G. Safety Regulations. It is strongly recommended that all participants wear an approved life jacket (PFD) at all times, especially while underway. Safety is the Most Important Rule of the Day!

4. DATE: Tournament date will be Saturday, June 26, 2021 "NO FOUL WEATHER DATE THIS YEAR"

5. FISHING HOURS: Will be the 9 hour period of time from exactly 6:00am until 3:00pm with a 3:30 check-in. You may depart your homport NO EARLIER than 5:30am, Absolutely No lines in the water before 6:00am !!!

6. TEAMS: A team will consist of Five (5) persons only per boat. At least one person on each team must be a member in good standing of an IBEW Local Union, (either active or retired) or an IBEW Signatory Contractor and will act as the CAPTAIN. The other four team members may be made up of family or friends.

7. ENTRY FEE AND REGISTRATION: All entries must be made on the Official 2021 Entry Form below and Received by the Tournament Treasurer not later than June 16, 2021 All Official Entry Forms Must be Mailed along with a check or money order made out to Wiremen's Credit Union for \$130.00 to the following address: ***** DO NOT DELIVER OR SEND ENTRIES DIRECTLY TO WCU*****

NOTE No entries can be processed after June 22, 2021 without the Director's Approval.

8. PERMITTED FISHING AREAS: Vessels may depart from any homport along the South shore of Lake Erie and may use any legal fishing waters of Lake Erie within the borders of the State of Ohio.

9. FISHING EQUIPMENT: All current 2021 State of Ohio Fishing Regulations will apply and each team will be allowed to use two (2) fishing rods in the water per person. Maximum of only (8) rods in the water per boat.

10. CONDITION OF FISH: Fish checked-in must be natural and kept on ice. No one will straighten, stretch, bend shake, freeze or in any way alter any fish. Anyone altering fish will be disqualified and fee forfeited.

11. MEASURING PROCEDURE: Each team will be allowed to check in a maximum of only 5 (five) Walleyes. Each fish will be measured in length only, to the least 1/8 of an inch. The team totaling the most inches will be declared the 1st Place Winners. In the case of a tie, the Official Tournament Judges will render a final decision.

12. CHECK IN: Check-in will begin at 1:00pm. All fish must be in line at the check-in station located at the E. 55th St. Marina by 3:30 pm (sharp). ***** ABSOLUTELY NO EXCEPTIONS FOR ANY REASON *****

13. BAD WEATHER CANCELLATION: Will be called by the Official Tournament director if at 5:30 am the Cleveland Area NOA has a Small Craft Warning in effect for the Cleveland Area. In case of a cancellation, the boxed lunch and a random drawing will be held to select winners at the check-in station on Saturday, June 26, 2021 at 3:00 pm. SHARP

14. CAPTAIN'S MEETING: One member from all teams must be present at the Mandatory Captain's meeting to be held at 7:00pm on Thursday, June 24, 2021 at the E. 55th St. Marina Check-in Area. "No Exceptions"

15. AWARDS: Will be presented immediately following the completion of the Judges tabulation or Random Drawing. Awards will be adjusted based on the number of entries. The following awards are based on a 35 boat field.
